CONTRACT FOR THE SALE OF A PET QUALITY PUG

_____ Hereafter known as Buyer agrees to purchase a Pug whose AKC Registration Number is _____ and is identified with an AVID microchip as _____.

This Pug's sire is _____ and its dam is _____ . A pedigree has been or will be provided to the Buyer along with AKC Registration papers by Woodcreek Pugs, hereafter known as the Seller.

The price of this Pug is _____ to be paid as follows: _____ and the following conditions are agreeable to both the Buyer and the Seller.

The above named dog is being sold as Pet Quality. This animal is purebred, registered or registerable, with the AKC, and is free of all disqualifying faults for this breed at the time of sale.

This puppy has been vet checked but the Seller recommends that you have this puppy examined by a licensed veterinarian within 24 hours of delivery. If the Buyer is unsatisfied with the health of the puppy within 7 days, the puppy may be returned to the Seller for a full refund.

In the event that the stated Pug is found to ever be unhealthy due to a proven hereditary condition within the first year of life (including confirmed Pug Dog Encephalitis, hemivertebrae or liver shunt) the Seller will replace the puppy as soon as one is available. We will not be responsible for problems due to breathing or eye issues (elongated soft palate, stenotic nares, or dry eye diseases for example). At no time will the Seller be held responsible for the veterinary, maintenance, or any other expense incurred by the Buyer after the purchase of this dog.

The buyer understands that this pug is being purchased as a pet/companion and will NOT be used for breeding.

The buyer of this puppy agrees to spay/neuter this puppy within 6 months of age and will provide evidence of this in writing from a licensed veterinarian. This must include the signature of attending vet as well as dates, address, telephone number, and a statement from the veterinarian that he/she verified identification of the pug by scanning and recording the pug's AVID microchip. The buyer also agrees not to sell or give this Pug to anyone else until it is spayed or neutered.

If this Pug is used to produce puppies that are sold or resold to dog wholesalers, pet shops, or to other commercial kennels or enterprises, or persons, or if ACCIDENTAL breeding occurs, the BUYER will be liable to the seller for the sum of \$1,000 PER LIVE PUPPY for damages. Seller will deposit monies into a trust fund, as directed by seller, solely set up for the lifetime of the litter, so that those puppies created will be cared for with the humane treatment that they deserve. Any and all lawyer's fees will be reverted to the buyer to bring this injustice to claim.

Both parties enter into agreement with the sincere intentions for the preservation of fine quality pugs with quality of life being top priority.

In the event it becomes necessary for either the Buyer or Seller to pursue litigation to enforce the terms of this contract, both parties agree to submit to the jurisdiction of the courts of Whatcom County, State of state of Washington, United States of America.
